#### **EXECUTIVE SUMMARY**

The market-led hand-holding exercise was carried out to establish business linkages between 15 FBOs in the West Mamprusi and Savelugu-Nanton Districts and other stakeholders in the value chain of commodities produced by the farmers. It is an apprenticeship approach to practical training which was carried out for the promotion and adoption of technology taught to the farmers during the Stage 1 and Stage 2-Part 1 MiDA training.

The CSIR-FRI carried out the Hand-holding exercise for 11 FBOs in the West Mamprusi and 4 FBOs in the Savelugu-Nanton Districts in the Northern Intervention Zone. The hand-holding exercise was carried out to directly establish horizontal and vertical linkages for the procurement/sale of agricultural inputs, warehousing, quality control, credit and organizational planning among the stakeholders.

To facilitate the establishment of business linkages among actors, stakeholders made up of tractor service providers, agro-input suppliers, agro-equipment fabricators, participating financial institutions, marketers and bulkers were brought together with farmers in the FBOs in a forum for discussion and to promote growth on 14<sup>th</sup> September 2010.

Information gathered was used to categorize and cluster the 15 Farmer Based Organizations (FBOs) for practical field demonstration on Good Agricultural Practices. The areas that were covered included the following:

- Appropriate site selection
- Adequate land preparation
- Use of improved seeds
- The practice of germination testing
- Planting distances
- Good nutrients, soil and water management practices
- Post planting measures such as weed and insect and disease pest control
- Maturity indicators
- Efficient harvesting techniques
- Post harvest management including cleaning, sorting, drying, milling and storage.

It is envisaged that the contacts established and the practical knowledge acquired by the FBOs will enable them to effectively commercialize their farming operations and also help the input suppliers, etc access new opportunities and markets offered by the improvement of the farming operations of the farmers in West Mamprusi and Savelugu-Nanton Districts.

#### **INTRODUCTION**

As part of its task order for Millennium Development Authority (MiDA), the CSIR-FRI provided an apprenticeship and mentoring approach to training for promoting technology adoption and industrial growth. This practical approach is known as Market- Led Hand-Holding.

The objective of the program was to ensure that the Farmer Based Organizations (FBOs) being trained by CSIR-FRI work towards the concept of value-addition in all spheres of their commercial farming activities. This activity was to be carried out together with supporting service providers or stakeholders. The Hand-Holding activity involved identifying these stakeholders in the value chain and the services they provide. CSIR-FRI helped to ensure that the needs of the FBOs were met with the stakeholders.

The Hand-Holding exercise is normally to start immediately after the Stage-2 Technical Training of the FBOs and is to run for about a 6-month period. Altogether, 15 FBOs were to go through the Hand-Holding exercise made up of 11 FBOs from the West Mamprusi District and 4 FBOs from the Savelugu-Nanton District. These were among the Phase 2 Early cluster of FBOs.

Implementation of the Hand-Holding exercise involved the following activities:

- Field activity training on demonstration farms or through farms of lead farmers in the community; and
- Linkages and negotiations with Participating Financial Institutions (PFIs), input suppliers, bulkers and marketers; and

In both activities above, there were a few changes after reflections before the implementation of the Hand-Holding activity was conducted.

A training plan for the Hand-Holding exercise was provided to the Regional Implementation Consultants (RICs) for approval before the commencement of the Hand-Holding exercise. The plan indicated what is to be done, how it would be done, who was to do what and when it would be done. The day-to-day activities of the exercise were coordinated by Mr. Seidu Ali Sampare, a member of the CSIR-FRI Technical Training Service Provider (TTSP). The list of participating FBOs is shown in Tables 1 and 2.

#### **FACT-FINDING MISSION**

In order to produce a practicable working plan for the Hand-Holding exercise, data on stakeholders was required. As such, a 3-member fact-finding Team from CSIR-FRI TTSP was commissioned and tasked to collect data from relevant stakeholders such as the Ministry of Food and Agriculture (MoFA), Regional Implementation Consultants (RICs), Participating Financial Institutions (PFIs), association of input suppliers and other important relevant entrepreneurs. The Team made up of Dr. (Mrs.) Margaret Atikpo, Mr. George Anyebuno and Mr. Seidu Ali Sampare embarked on the fact-finding trip to the West Mamprusi District operational area, Tamale Metro and the Bolgatanga Municipality to collect the data.

#### **Data Collection**

The Team was to look for the necessary data to make the Hand-Holding exercise successful. The first point of call was the Northern Regional Director of Agriculture's office in Tamale on the 28<sup>th</sup> June 2010. The MoFA Northern Regional Director Mr. Joseph Faalong met with the Team where they obtained an up-dated list of agro input and other service providers in the region from the Management Information System (MIS) Officer.

The next point of call was the RICs office at Nyankpala, where an unscheduled meeting was held. In attendance were Mr. Joseph Bapule, Mr. Musah Taylor, Mr. Owusu and Mr. Zechariah Naandam Biimi. After general discussions, the Team requested to have the list of PFIs and the exact locations of the demonstration farms. The list of the PFIs was furnished to the Team by the RICs. The RICs then directed the team to make contact with The Center for Sustainable Local Development (CSLD) in Tamale, which was contracted to set-up the demonstration farms in the West Mamprusi District. Mr. Awal of CSLD described the exact locations of the demonstration farms. The farms were at three locations namely Nanton and Diarre in the Savelugu-Nanton District and Wungu in the West Mamprusi District. The team also visited a demonstration farm in front of the RICs office at Nyakpala and was taken round the farm by the Farm Manager.

The Team next visited the MIS Officer at the Upper East MoFA office in Bolgatanga to collect data. The Walewale District MoFA office was the last point of call where the Team obtained a list of input suppliers in the District.

Finally, the Team visited almost all the CSIR-FRI FBOs within the West Mamprusi operational area and requested the individual executives of the FBOs to select a Lead Farmer whose farm could be used for the practical demonstrations.

## **TRAINING PLAN**

A training plan was drawn up after careful study of the data obtained from the fact-finding mission. In drawing the plan, a format presented by the RICs was used as a guide. A tentative plan was then delivered to the RICs for their perusal. The training plan is shown in Appendix 1.

#### **CATEGORIZATION AND CLUSTERING**

Being so vast and not easily accessible during the yearly major raining seasons, there was the need to categorize and cluster the FBOs in the West Mamprusi District for easy implementation of the demonstration farm field activities. Four FBOs which were in the Savelugu-Nanton District had to be clustered separately.

A total of 5 FBO clusters were made as shown in Table 3. Cluster 1 involved all FBOs in communities between the Nasia-Karemenga stretch on the Bolgatanga-Tamale road. Cluster 2 consisted of FBOs in communities in and around Mishio and Bulbia, on the Walewale Hospital road. Cluster 3 was made up of FBOs in 3 communities located after the Kpasenkpe Bridge in the environs of Kunkwak. Cluster 4 involved FBOs in the main overseas communities. Lastly, Cluster 5 was in the Savelugu-Nanton District and the communities were between Zoggo and Zoonayili off the eastern part of Savelugu, the district capital of the Savelugu-Nanton District.

#### FIELD DEMONSTRATIONS ACTIVITIES, RICs AND LEAD FARMER CONCEPTS

Mr. Awal of the Centre for Sustainable Local Development (CSLD) introduced two MoFA AEAs, Messrs. Ibrahim Abudu and George Bashiru as responsible for the demonstration farms. Mr. Abudu was in-charge of Wungu farms in the West Mamprusi District while Mr. Bashiru was responsible for the Nanton and Diarre farms in the Savelugu-Nanton District.

Contact was made with the AEAs and the program of activities was presented and explained to them. Table 4 shows the time schedules and the trainers of each FBO. Due to the very long distances to some of the communities from the demonstration farms and the recent floods that cut off communities especially in the 'overseas' areas, the lead farmer concept was employed to teach members of the FBOs. The communities were Wuntubri, Tuuvu, Yezesi, Kubagna, Goriba, Kunkuwak, and Jadema.

A minimum of 5 farmers from each FBO per Cluster was transported to the demonstration sites for each day of the field activity. After the field demonstrations, members of each FBO were expected to go back and organize a forum to brief the rest of the FBO members who did not attend the training about the practical critical steps along the production chain of various focus crops that were observed on the field.

Communities which were closer to the RICs demonstration farms had many more farmers who attended. Many of the farmers came by bicycles and motor-bikes to the farms. For the lead farmer option, almost all the farmers present in the community attended. The farmers listened attentively to the facilitators and asked a lot of questions. Generally, the lead farmer approach was more interactive and observations indicated that farmers enjoyed this approach better.

The field activities started with a brief introduction of trainers, AEA, facilitators and the FBO members present. The Program Coordinator then gave on overview and exemplification of the technical details of the commercial development of Farmer Based Organizations and the crop productivity development training. Commodity and the value-chain concept were again reiterated.

For both training approaches, emphasis was laid on adoption of good management practices and timely cultural practices to enhance productivity. Methods on how to achieve very good yields through the adoption of Good Agricultural Practices (GAP) were highlighted. These included:

- Appropriate site selection
- Adequate land preparation
- Use of improved seeds
- The practice of germination testing
- Planting distances
- Good nutrients, soil and water management practices
- Post planting measures such as weed and insect and disease pest control

- Maturity indicators
- Efficient harvesting techniques
- Post harvest management including cleaning, sorting, drying, milling and storage.

The need to choose a market-driven variety was elaborated. To avoid the use of poor seed, farmers were advised to buy seed from accredited agents, since the planting of poor seed has poor germination implications.

Training on pegging to achieve the desired inter- and intra-row spacing, planting method, date of planting, weed management and the application of herbicides were highlighted. Effective fertilizer application was also demonstrated. Bird control methods were mentioned for the rice production groups in particular and the need to harvest at the right time in order to eliminate field-to-store pests was also mentioned.

The AEAs and trainers present also made some inputs on the environment, the proper use of herbicides, pesticides and the disposal of their containers. A visit to the field in order to observe demonstrations of all the critical phases of production was carried-out. The farmers were allowed to asked questions and the relevant answers were provided by the facilitators. Most of the questions asked by the farmers centered on insect pests and their control. One of the trainers of CSIR-FRI, Dr. Kwame Vowotor who is also a Crop Scientist gave an overview on plant diseases, their management and controls, to the satisfaction of the farmers. The farmers were happy with the hands-on nature of the program and prolonged the questioning till all activities were exhausted on the field.

Two demonstration farms were sighted in the West Mamprusi District which belonged to WIENCO and JAICA. The two farms were situated in the Jadema and Wungu communities, and were cropped with maize and rice, respectively.

#### STAKEHOLDERS MEETING AND PRESENTATIONS ON MARKET LED LINKAGES

A meeting was organized between the stakeholders and all the FBO representatives in the West Mamprusi District and Savelugu-Nanton Districts at the West Mamprusi District Assembly Hall on 14<sup>th</sup> September 2010. This meeting was held because the stakeholders claimed it would be very difficult or impossible for them to be going round the FBOs in the different communities to explain the farming related issues to the farmers in the FBO.

About 40 stakeholders made up of Participating Financial Institutions (PFIs), tractor services operators, agro input dealers, marketers and bulkers were invited for the meeting. The list of the stakeholders is shown in the Appendix 2. Over 30 farmers from the 15 FBOs in the 2 Districts attended the meeting.

The Chairman of the meeting, Dr. Kwame Vowotor, welcomed all members after a self introduction of all participants. He spoke about the MCA Ghana Compact and the US\$547 million the American government donated for programme. Dr. Vowotor spoke also on Millennium Development Authority (MiDA) as the managing authority and the components of the Ghana Compact which are Agriculture, Transportation and Social Services. He mentioned the zones that are benefiting from the program, i.e. the Northern Agricultural Zone (NAZ), Afram Agricultural Zone (AFAZ) and the Southern Horticultural Agricultural Zone (SHAZ). He also briefly spoke about the Hand-Holding excise, stressing on its relevance and importance to the FBOs. The Coordinator of the Hand-Holding exercise, Mr Seidu Ali Sampare was then introduced to continue with the strategies for market-led hand-holding meeting.

The Coordinator explained that the exercise was an apprenticeship approach to the training already conducted for the FBOs and was to lead to the promotion and adoption of technology and industrial growth. He reiterated on the commodity step to the market and emphasized the stepwise task of the value chain activities and their linkages with players in the market.

Emphasis was also given on activity planning and scheduling to meet market requirements. The Coordinator said it would not come easy unless FBO's effectively strategized and allowed all subcommittees of the FBO to work within the organizational plan for member involvement. Otherwise, the dream of meeting the provisions in their Business Action Plans (BAPs) would elude them. It was emphasized that the richness of FBOs ability to institutionalize self management would make technical assistance in loan and credit enhancement better. The Coordinator lamented that many more entrepreneurs would come on board if quality controls, current value adding activities, technical assistance arrangements, credit arrangements, input supplier relationships, contract relationship and marketing arrangements are guaranteed. Finally, it was emphasized that all the service providers should form registered associations and make themselves known to the Participating Financial Institutions (PFIs).

#### The Participating Financial Institutions (PFIs)

Mr. Mohammed Musah and Khadija Shanni, representatives from the Agricultural Development Bank (Tamale Main and Aboabo) and Mr. Fuseini Suf-yan of the Bangmarigu Community Bank (Walewale) took turns to explain the detailed conditions and other criteria to be met to enable the bank to disburse monies to the FBOs. The representatives of the PFIs noted that access to credit was not as simple or a straight forward service and that many more factors come into play before credit is accessed. The representatives indicated the awareness of the banks to work very fast to meet timely crop cultivation schedule in order for the cropping calendar to be met. They think that farmers are always in a hurry for credit and think procedures should be skewed to their favour. The bankers promised that as professionals, they would work hard to satisfy all involved with the programme. They indicated that loan recoveries have not been easy at all and were appealing to farmers to pay back loans promptly. It was also said that the banks are working around the clock to recover monies that have been disbursed.

Mr. Fuseini Suf-yan of the Bangmarigu Community Bank Ltd enriched the session by further explaining to farmers the technical assistance in loan application, follow-up and credit management advice. An application material has to be filled on behalf of the members and each member was to open a personal account, where necessary cash lodgment could be made. Since some monies were not to be paid directly, all stakeholders who render any approved service would have their payments made after consultation with the FBO executives.

#### **Tractor Service Providers**

Mr. Jacob Sule of Daribio Farms in Yama who represented tractor service providers within the district spoke of how difficult it has become to provide ploughing services especially in the overseas area. He noted that there were enough tractors in the District to do the job and therefore recommended that the tractor service providers come together to form an association.

He lamented that the fields of farmers was far from each other and that one has to criss-cross the community to plough farmlands. He then suggested that a special look be taken to lessen this burden. He mentioned that MiDA could work on some pre-financing arrangement to cater for the purchases of fuel for ploughing. Agreeably, he insisted that farmers should persist in the demand that tractor operators plough according to the standard one-acre measurement of about 64m x 64m.

#### **Agro-Input Suppliers**

Wunpini Agro and Ganorma Agro Chemicals spoke on behalf of agro-input suppliers. It was mentioned that most of the agro-input suppliers were agents of the bigger supplying companies and they could be found almost everywhere in the region and the districts. They were however not happy when they were not considered in the MiDA tendering process to supply of inputs for the FBOs. Pledges were made to the farmers about the supply of all the major inputs. He finally said it would be possible if the farmers were united so that costs could be negotiated effectively.

#### **Marketers and Bulkers**

Zakaria Alhassan of Gundaa Enterprise represented marketers and bulkers. He said as bulkers they had the capacity to buy all produce at the farm gate. He added that if farmers were very united, some of the bulkers have the capacity to give tractor services and credit. However he mentioned that agreements and MoUs must be honoured to avoid unwanted legal battles. He mentioned that everyone had the right to make a reasonable margin in a business.

### **QUESTIONS AND ANSWERS**

The representative of MiDA in Tamale Mr. Ibrahim Alabira who was meeting with FBOs in communities around Wulugu, precisely Kurugu, Kpatusi, Kparipiri and Suhuluya managed to be at the function despite the day's tight schedule. Some questions posed by the farmers and answered by Mr. Alabira are shown below:

Que: Why was MiDA credit not forth coming?

**Ans:** Because loan recovery has been poor. He requested all stakeholders, especially the farmers to pay up promptly.

Que: Why could FNGOs not recover loans?

**Ans:** Some farmers were not willing and most of them were misinformed though this was treated in the capacity building training.

Que: What was the interest rate?

Ans: Interest rates are not fixed and would be known anytime credit was disbursed.

Que: Why were local Input suppliers sidelined in tendering?

**Ans:** The tendering processes are always advertised and open to everyone the world over.

Que: Why is tractor service providers not pre-financed to buy fuel?

**Ans:** MiDA does not do pre-financing in any of its programs. You need to have the initial capacity to deliver and it is always made known to all would-be tenders. However, it is advised that small capacity firms could come together to bid in such large-scale bidding processes.

Que: Why can't the banks employ more credit officers?

**Ans:** Employment needs to be justified.

#### STAKEHOLDER INTERACTIONS AND LESSONS LEARNT

Stakeholders had the opportunity to freely interact and also make contacts. Participants were observed making contacts with the stakeholders and service providers. There was no doubt that some links with the farmers had been established.

#### **Lessons learnt**

A number of lessons were learnt. These include the need for:

- more open communication channels to all stakeholders;
- managerial skills to plan and organize members to access the loan facility which was very crucial to the survival of the program;
- linkage with input suppliers;
- linkage with buyers to encourage continuous production;
- more on-farm demonstrations;
- acquisition of post-harvest and processing machines

#### **CONCLUSIONS**

The FBO members indicated how the MiDA Programme had enlightened and informed them about what exploits they can achieve through commercialization of farming. They indicated that they have gained considerable knowledge through the Hand-holding exercise especially when farming is taken as a business. They said that they are now better informed to involve relevant input suppliers as partners in agriculture and to cost their farming activities to see which crops are more profitable to grow as a commercial venture.

The Hand-holding excise was successful; more than 90% expected stakeholder attended. The farmers were content with being part of the hands-on approach to the cultivation of their crops. The exercise offered farmers the opportunity to have better understanding on the need for linkages and how they operate in order to efficiently undertake value-chain activities.
